  - The vocal duet (Naomi Budziszewski and Missy Hanson) earned an Excellent Rating.

- We are proud of the Tri-County Concert Choir for earning all Superior Ratings at the Sub-Section Large Group Choir Contests held at GMR on March 12. The choir earned some of the highest scores of the day and received numerous compliments on their high-quality performance.
