Amend Resolution to renew membership in MN State High School League

This is a "re-do." A resolution to Renew Membership in MN State High School League was on the May 17, 2023 regular Board meeting Agenda. The resolution was brought forward. In the discussion that followed [TCS student interest surveys] the Board "just forgot" to get a second before voting. So, to be official the Board needs a motion, a second and vote.

Minnesota Statute requires individual school boards each year to authorize membership in the MNSHSL. The Resolution for Membership affirms; (1) that the Board of Education for each school delegates the control, supervision and regulation of League-sponsored athletic and fine arts activities to the MNSHSL; (2) that the School Board adopts the Constitution, Bylaws, and Rules and Regulations of the League; and, (3) that the administration for and activities are assigned to the official school representative.

Amend resolution brought forward during the May 17, 2023 to have Board Member Koland introduce the Resolution and seconded by Burkel to renew the Tri-County School District's membership in the MN State High School League for the 2023-2024 School Year.

#### RESOLUTION DISCONTINUING AND REDUCING EDUCATIONAL PROGRAMS AND POSITIONS

Member Hanson introduced the following resolution and moved its adoption:

#### RESOLUTION DISCONTINUING AND REDUCING EDUCATIONAL PROGRAMS AND POSITIONS

WHEREAS, the School Board of Independent School District No. 2358 adopted a resolution

on January 18, 2023, directing the administration to make recommendations for reductions in

programs and positions, and

WHEREAS, said recommendations have been received and considered by the school board,

BE IT RESOLVED, by the School Board of Independent School District No. 2358, as follows:

That the following programs and positions, or portions thereof, be discontinued:

1. Reduction in the Full Time Equivalency (FTE) of the District Technology position from 12 month employee to 11 month employee.

whereupon said resolution was declared duly passed and adopted.

Approval of Revised & Amended Joint Powers Agreement as per Joint Powers Board meeting held on June 5, 2023.

**Description:** A Joint Powers Agreement between the Greenbush Middle River School District and the Tri-County School District was established to share a School Superintendent effective with the 2023-2024 school year. The Agreement was developed with the assistance of the MN School Boards Association (MSBA).

Various issues associated with the actual implementation of the Joint Powers Agreement resulted in the original Joint Powers Agreement needing to be amended.

Motion by Board member Koland and seconded byBurkel to approve the amended Joint Powers Agreement as recommended by GMR Joint Powers Board representatives.

Motion to terminate previously approved Superintendent Agreement and recommend approval of a revised Agreement based on Joint Powers revisions.

**Description:** Board approval of a revised and Amended Joint Powers Agreement, results in a recommendation to terminate a previously approved Superintendent Agreement and replace that Agreement with a revised Superintendent Agreement.

Enter into Agreement via Superintendent Services Contract to Share Superintendent with Greenbush Middle River School District.

Motion by Board MemberOliver and seconded by Koland to enter into Agreement via Superintendent Services Contract to share the Superintendent of School with the Greenbush Middle River School District.

## SUPERINTENDENT SERVICES CONTRACT between THE SCHOOL BOARD OF TRI-COUNTY PUBLIC SCHOOLS (ISD # 2358) AND THE SCHOOL BOARD OF GREENBUSH-MIDDLE RIVER PUBLIC SCHOOLS (ISD # 2683)

The School Boards of Tri-County (ISD #2358) and Greenbush-Middle River (ISD # 2683), hereinafter referred to as "the Boards", enter into the following agreement to share superintendent services.

### Services to be Performed

ISD #2358 will employ a superintendent of schools, jointly selected by the GMRTC Joint Powers Board, to provide superintendent duties for both school districts. This superintendent will execute their duties on a 50-50 basis to each school district. The Superintendent shall hold a valid Superintendent's license issued by the State of Minnesota. The Superintendent shall have charge of the administration of the schools under the direction of the Boards. The Superintendent is an exofficio, non-voting member of the Boards and performs the duties of the office of Superintendent.

#### **Evaluations**

An annual performance evaluation will be conducted by the GMRTC Joint Powers board with input from the Boards.

### <u>Term</u>

This Superintendent Services Contract will become effective for a term of 3 years commencing on July 1, 2023. Upon agreement of ISD #2358 and ISD #2683, this contract may be renewed prior to the expiration date

### <u>Costs</u>

For the superintendent services, ISD # 2683 will pay ISD # 2358 the following:

- 50% of all costs related to the execution of the superintendent contract.
- 50% of all other expenses such as, but not limited to, mileage, professional dues, convention expenses and any other incidentals that are incurred by the superintendent in the performance of their duties.

These expenses will be billed in quarterly installments and are due Net 30.

#### Termination:

This agreement remains in force through the term of the agreement or until mutual termination of the Boards. If one board of ISD #2683 and ISD #2358 wishes to unilaterally terminate this contract, they shall provide written notice to the other school board in writing by July 1 and the termination will be effective July 1 of the following year.

Notwithstanding the foregoing, either party may terminate this agreement upon a material breach of the Agreement by the other party by delivery of a thirty (30) days' prior written notice. If the receiving party has not cured such a breach within such a period, then the Agreement will automatically terminate upon conclusion of the thirty(30) day notice.

#### Applicable Law:

The Agreement shall be governed by and construed in accordance with the laws of the State of Minnesota.

#### <u>Severability</u>

The provisions of the Agreement shall be severable, and if any such provision or the application of any such provision under any circumstances is held invalid, it shall not affect any other provisions of this Agreement or the application of any provision thereof.

The MN School Boards Association (MSBA) is an organization specific to School Board members.

- Tri-County School District currently is a member of the Minnesota School Boards Association
- Membership dues are required annually
- MSBA assists the Tri-County School District on a variety of issues such as policy development, negotiations, human resources, advice based on legal precedent, legislative lobbying

A motion was made by Board Member Sollund seconded by Burkel to renew the District's annual membership with the Minnesota School Boards Association (MSBA).

MREA advocates exclusively for Greater Minnesota School Districts. MREA provides guidance and information relating to best practice within education, professional development opportunities as well as legislative policy.

- MREA provides a voice at the Minnesota Legislature advocating for policy, testifying before committees as well as informing legislators on the issues that impact rural education.
- Membership dues are required annually (discount applies to Tri-County School because of "sharing" Superintendent with Greenbush Middle River.

A motion made by Board Member Oliver seconded by Hanson to renew the District's annual membership with the Minnesota Rural Education Association (MREA). Renew membership in Minnesota Rural Education Association (MREA)

10.4 MN Statute 123B.77 indicates that prior to July 1 of each fiscal year, the Board of each school district must approve and adopt its revenue and expenditure budgets for the next school year. The budget document so adopted must be considered an expenditure-authorizing or appropriations document. No funds shall be expended by any Board or district for any purpose in any school year prior to the adoption of the budget document which authorizes that expenditure, or prior to an amendment to the budget document by the board to authorize the expenditure.

Member Oliver introduced the following resolution and moved its adoption:

BE IT RESOLVED by the School Board of Independent School District No.2683, State of Minnesota, as follows: Designation of an Identified Official with Authority for Education Identity Access Management

The Minnesota Department of Education (MDE), Professional Educator Licensing Standards Board (PELSB), and Office of Higher Education (OHE) require annual designation of an Identified Official with Authority (IOwA) for each local educational agency that uses the Education Identity and Access Management (EDIAM) system. The IOwA is responsible for authorizing, reviewing, and recertifying user access for their local educational agency in accordance with the State of Minnesota Enterprise Identity and Access Management Standard, which states that all user access rights to Minnesota state systems must be reviewed and recertified at least annually. The IOwA will authorize user access to State of Minnesota Education secure systems in accordance with the user's assigned job duties, and will revoke that user's access when it is no longer needed to perform their job duties.

The Tri-County School Board must designate an IOwA to authorize user access to State of Minnesota Education secure websites for its organization. This EDIAM board resolution must be completed and submitted to the Minnesota Department of Education annually, as well as any time there is a change in the assignment of the Identified Official with Authority.

It is strongly recommended that only one person at the local educational agency or organization (the superintendent or exec. director) is designated as the IOwA. The IOwA will grant the IOwA Proxy role(s). Designation of the Identified Official with Authority for Education Identity and Access Management
