The meeting was called to order by Chairperson Wikstrom at 8:00 p.m. and a quorum was determined. The Pledge of Allegiance was recited.

"We Are Proud"

- We are proud of the junior class for the work they put forth to make a successful prom again this year. There were many compliments on this year's decorations.
- We are very proud of all students in 2nd 11th grades for taking all the spring tests seriously. They've had multiple tests with the MCA's and NWEA's in math, reading, language and science.
- We are extremely proud of the Brilliant Bricks LEGO Robotics team for earning a 3rd place trophy in "Innovative Robot Design" at the National Open Championship tournament in Dayton, Ohio. The tournament participants came from 42 states and included Alaska and Hawaii. Many of the teams at this tournament had been to the World Festival (the pinnacle of LEGO tournaments) in the past few years. The Robot and Technical design judges were so impressed by the system for putting on attachments, called "Quick-Tatch" by the team, that they suggested the team apply for a patent on this intellectual property. They were dead serious about applying for the patent! Mr. Thompson is currently checking on what the patent application will entail.

The team was also nominated for the "Rising Star" award by the teamwork judges. This award recognizes a team's potential for growth in future years of competitions. Though they did not win this award, it was an honor to be recognized for all the work they did this year. The team members represented themselves and the school proudly and were very good on the trip. The days were long and there was not much time for rest, but they kept at it, always keeping a positive attitude, even when things didn't work as well as they wanted with the robot. The robot that the team completely re-built after the North Dakota State Tournament scored a 235 out of 400, which earned them 26th place out of 60 teams!

Participants in the LEGO League must be between the ages of 9-14 and our team fell directly in the middle of the competition age group. Team participants included:

Michael Thompson--6th grade, Josh Grochowski, Faith Conway, Bennett Amb, and Josie Nobles---all 5th graders. Taylor Rux, another 5th grade team member, was not able to attend the tournament, but participated in all elements of design and research for this year's team.

- The Envirothon has advanced to the state competition this year. The team includes Josh Guillemette, Becca Larson, Spencer Knutson, Carrie Engen, and Tony Sang. They placed third out of 17 teams at the Area Envirothon held at Lake Bronson State Park. They competed in six categories: Forestry, Aquatics, Wildlife, Soils, Current Events, and a presentation on Biodiversity. The state Envirothon will be held at Ironwood Springs Ranch in Stewartville, MN.
- I am extremely proud of my two seniors, Kim Nyflot and Kristine Ramsrud, who make up my entire Journalism class. Since we print, fold, count, and bundle all 1,000 plus papers each month, these girls have literally put together 8 issues of this year's Cat Tales, as well as written all of the articles. They have also put in many hours working on the 2009 yearbook. Both the paper and the yearbook take a great deal of dedication and time since throughout the entire school year, events have to be attended, pictures have to be taken, to say nothing of articles written and pages put together according to definite timelines. They have both been in Journalism for two years and I applaud them for all they have contributed to the Journalism program. They will definitely be missed!
